WHEREAS Canada anticipates a shortage of 78,000 doctors by 2031 and 117,600 nurses by 2030; [1]

WHEREAS Canada gives priority to selecting permanent residents with healthcare experience; [2]

WHEREAS only 58% of internationally-educated healthcare professionals in Canada are employed in healthcare; [3]

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Promote international and bilateral cooperation to provide provinces the tools to develop a standardized qualifications process that reduces the administrative burden for foreign credential recognition;
- Work with provinces and territories to provide them with tools to assess the feasibility and desirability of having internationally-educated health professionals complete foreign credential recognition and bridging education in their country of origin, so they can arrive in Canada licensed and ready to work;
- Work with provinces and territories to provide them with tools to allow their regulatory bodies process foreign credential recognition without undue delay;
- Work with provinces and territories to provide them with tools to promote opportunities for foreign credential recognition and ensure bridging education opportunities are available to immigrants admitted as healthcare professionals without a significant financial burden;

48052 – ENFORCING THE CANADA HEALTH ACT AGAINST PRIVATIZATION: DEFENDING UNIVERSAL HEALTH CARE

Sponsor Groups: Liberal Party of Canada (Alberta)

WHEREAS provincial governments are increasingly contracting private surgical and diagnostic providers at higher costs that, divert federal health transfers from public care; [1]

WHEREAS some Canadians are being billed out of pocket for services that are medically insured under the Canada Health Act, undermining the principle of universal access; [2]

WHEREAS hospital operating rooms remain underused as nurses and anesthesiologists migrate or are directed to private clinics, worsening surgical wait times; [3]

WHEREAS Section 12(1) of the Canada Health Act mandates that provinces negotiate service prices with recognized professional organizations, not with individual contractors or for-profit clinics; [4]

WHEREAS Alberta's pivot from publicly delivered to privately contracted health care services is setting a precedent that normalizes profit-based models across Canada, undermining universal health care and equal access to essential health/hospital services. [5]

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Direct the Minister of Health to initiate formal consultations with provincial Ministers of Health regarding contracting for-profit surgical/diagnostic and hospital services and its impact on public accessibility and wait times;
- Incentivize standardized evidence-based annual provincial reporting on levels of private contracting, associated costs to the taxpayer, and effects on service accessibility, under the Canada Health Act;
- Review the Canada Health Act to initiate amendments to strengthen universal health care across Canada.

71261 – ACHIEVING HEALTHCARE FOR ALL CANADIANS: A 21ST CENTURY RESTRUCTURING OF THE HEALTHCARE SYSTEM

Sponsor Groups: National Women’s Liberal Commission

WHEREAS we have 2 tiers of access to healthcare in Canada, with six and a half million Canadian adults in the tier that does not have access to primary care; [1]

WHEREAS the Canada Health Act (1984) has not evolved with the changing health care system, as it guarantees insurance coverage only for care provided either in hospitals or by physicians, (nurse practitioners, pharmacists and midwives will also be included starting April 1, 2026); [2]

WHEREAS most healthcare should take place in the community and many healthcare services can be provided by other health professionals; [3]

WHEREAS there is an abundance of evidence that countries with strong systems of primary health care get the best health outcomes for their population, at the most affordable costs, in a way that is both equitable and accessible; [4]

WHEREAS in her recently published book, Healthcare For All (2024), Jane Philpott, MD and former Minister of Health, describes a holistic approach to achieving the goal of providing a “primary health care home” for all Canadians within 10 years.

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Take a leadership role in restructuring health care in Canada as outlined in Jane Philpott’s book Healthcare For All, including introducing federal legislation in the form of a Canada Primary Care Act, using its spending power to link a portion of the Canadian Health Transfer – or a separate transfer – to primary care with the goal of providing universal, authentic access to primary care for all Canadians within 10 years.

46067 – EXPANDING PHYSICIAN TRAINING CAPACITY TO ADDRESS CANADA'S HEALTH CARE CRISIS

Sponsor Groups: Liberal Party of Canada (Manitoba)

WHEREAS Canada is facing a critical shortage of physicians, with over 6.5-million Canadians lacking access to a family doctor and Manitoba reporting one of the worst physician shortages in the country; [1] [4]

WHEREAS Canada trains fewer physicians per capita than most OECD countries, producing only 7.5 graduates per 100,000 population, compared to the OECD average of 14.23; [2]

WHEREAS Decades of policy decisions to reduce medical school and residency seats, including Manitoba's cuts from 100 to 70 seats in the 1990s, have resulted in a loss of over 800 potential physicians in Manitoba alone; [2] [3]

WHEREAS Limited residency spots and complex licensing requirements prevent internationally trained physicians from entering practice; [5]

WHEREAS Physician burnout and early retirement are worsening the crisis – 47% of Manitoba doctors report burnout and 46% plan to retire, leave or reduce hours imminently; [4]

WHEREAS Provinces are competing with one another and internationally to recruit physicians, rather than investing in sustainable domestic training capacity; [5]

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Substantially increase federal funding to post-secondary institutions and health authorities to expand medical school and residency positions across Canada;
- Establish a national strategy to align training capacity with projected population health needs;
- Reform the Canada Health Transfer to include conditional funding tied to measurable increases in physician training capacity.
- Collaborate with provinces to streamline residency and licensing for foreign-trained doctors in Canada;

10220 – AGEING IN PLACE: THE ROLE OF THE MUNICIPALITIES

Sponsor Groups: Liberal Party of Canada (Newfoundland and Labrador)

WHEREAS with Canada's ageing population, supporting older adults to remain safely and comfortably in their homes has become essential;

WHEREAS municipalities are best positioned to lead this effort, as they understand local needs and can design targeted programs and services including health services;

WHEREAS municipal leadership in aging in place promotes:

- Preventive and supportive local services
- Improved accessibility and infrastructure
- Tailored community programs
- Reduced social isolation and enhanced intergenerational engagement
- Partnerships and coordinated service delivery

WHEREAS priorities to strengthen ageing-in-place strategies require that municipalities should:

- Provide homeownership supports such as home adaptations, repairs, and mortgage relief
- Expand rural health services through new healthcare teams and access programs
- Enhance community supports including transportation, digital inclusion and environmental initiatives such as snow removal

WHEREAS Seniors through their local Community Team can be ensured that they will have:

- Access to health care specialists
- Be treated within a continuum of care
- Access to long-term care in an appropriate setting at home
- Practical support to age in place at home
- Community based organizations to support seniors
- Comprehensive electronic records from a full spectrum of health care professionals to facilitate and enhance in-person and virtual care services efficiency

WHEREAS collaborative governance requires coordination among federal, provincial, and municipal governments as well as with community organizations;

WHEREAS integration of municipal, healthcare, and community systems requires a comprehensive Aging at Home Framework with appropriate funding from federal and provincial sources.

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Promote Aging-in-place principles to be embedded in municipal plans, zoning, transportation, recreation, food systems, and housing strategies.
- Embed these principles across planning and governance, enable seniors to age with dignity, independence, and security.

- Support and promote the establishment of appropriate health care services at the municipal level for those wishing to Age in Place.

74312– PROTECTING CANADIAN YOUTH FROM SOCIAL MEDIA HARMS

Sponsor Groups: National Caucus, Liberal Party of Canada (Quebec)

WHEREAS young Canadians aged 11 to 17 spend over three hours per day on social media platforms ("Platforms"), and studies link such use to increased psychological distress, anxiety, and sleep disorders

WHEREAS Canada gives priority to selecting permanent residents with healthcare experience; [2]

WHEREAS youth face risks online, including cyberbullying, extortion, sharing non-consensual images, hateful content, addicting design features that harm mental health

WHEREAS Australia adopted robust legislation setting a minimum age of sixteen for social media accounts and imposing age-assurance, privacy, and safety obligations on Platforms

WHEREAS international best practices require Platforms to prevent underage account creation and reduce harmful design features, deepfake images, unsafe online interactions; and

WHEREAS Canada's Bill C-63 addresses certain online harms but fails to set a minimum age for social media accounts.

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Set a minimum age of sixteen for creating social media accounts, placing an obligation on Platforms to prevent under-age users from holding accounts;
- Establish a regulatory framework requiring Platforms to use effective age-assurance tools, meet appropriate safety and privacy standards, eliminate harmful or addictive design features, protect minors from unsafe online interactions, and prevent and remove deepfake or synthetic images of non-consenting individuals;
- Give Government the authority to define and update which Platforms are covered, focusing on those posing the highest risks to youth;
- Create a digital safety body to monitor compliance, conduct audits, issue notices, and apply penalties;
- Provide a reasonable period for industry to prepare;
- Invest in digital literacy and mental health supports for youth; and
- Require a review within two years of implementation.

70049– TAX EQUITY FOR SINGLE SENIORS

Sponsor Groups: Senior Liberals' Commission

WHEREAS single seniors (never married, widows/widowers, divorced) pay significantly more income taxes than senior couples with identical incomes (e.g. 2024 tax year - singles income - \$30-\$40K - pay \$1,200-\$3,400 more; at \$50K, \$5K more; at \$70K, \$7K more) [1];

WHEREAS single seniors pay many of the same non-discretionary expenses as couples: rent, mortgages, property taxes, telecom, insurance, etc.;

WHEREAS every Senior Couple eventually becomes a Single Senior (death or divorce);

WHEREAS pension income splitting advantages the income of senior couples, an advantage not available to senior singles; [2]

WHEREAS non-refundable tax credits disproportionately benefit senior couples over single seniors [3];

WHEREAS there is no government program that can currently address these inequities;

WHEREAS the Liberal Party has committed to the values of fairness, equity and inclusion;

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Recognize Single Seniors as a distinct citizen stakeholder group with equity disadvantages;
- Commit to consider improvements to Federal tax policy to rectify the disparity in tax equity between Single Seniors and Senior Couples.

60186– RESOLUTION FOR INCREASING AND INDEXING THE NORTHERN RESIDENT DEDUCTION

Sponsor Groups: Liberal Party of Canada (Territories)

WHEREAS the cost of living in the North is significantly higher than in other regions of Canada, as evidenced by the Territories having higher average household expenditures than income levels, contributing to a unique financial strain on residents;

WHEREAS the Northern Resident Deduction (NRD) was established in the late 1980s to alleviate some of these costs for residents of prescribed northern zones by providing a daily tax deduction, yet it has not kept pace with inflation;

WHEREAS the basic residency amount under the NRD has remained at \$11 per day since the last increase in 2016, which according to the Bank of Canada, would be equivalent to approximately \$13.56 today due to inflation;

WHEREAS an adjustment for inflation would ensure the deduction continues to meet its goal of attracting and retaining skilled labour in northern regions, promoting fairness and economic stability;

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- index the Northern Resident Deduction to inflation to better reflect current economic realities and increase the day rate from \$11 to \$13.56, ensuring the NRD evolves with changing economic conditions and continues to provide meaningful support to those living in the North.

24360 – RESTRICTING ACCESS TO AI AND CHATBOTS FOR CHILDREN AND TEENS

Sponsor Groups: Liberal Party of Canada (Quebec)

WHEREAS AI and chatbots are having negative effects on the mental health of Canadian children and teens leading directly to a range of harmful behaviours. These technologies have been shown to limit desire for interaction with peers, pushed some young people into sexual conversations and have even recommended suicide to vulnerable youth.

WHEREAS numerous cases in the US, overseas and here in Canada have shown these platforms cause loneliness, depression and feelings of inadequacy, particularly in teens.

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- impose an age restriction of 16 years on access to all AI chatbots and other potentially harmful forms of AI interaction. This includes AI technologies capable of carrying on a discussion or providing "advice," such as Chat GPT, Character.AI, Nomi, Replika, Janitor AI and all the others.

Exceptions may be made for AI powered chatbots built into the customer service offerings of legitimate businesses supporting customers, such as airline, telecom companies, retail shops and others. In those cases, copies of such conversations must be accessible to the user, making it easy to report any potential improper performance on the part of the bots.

47189- ELIMINATING THE VISA REQUIREMENT FOR UKRAINIAN CITIZENS

Sponsor Groups: Liberal Party of Canada (Saskatchewan)

WHEREAS Canada has supported Ukrainian immigration for over 130 years and was the first Western nation to recognize Ukraine's independence in 1991.

WHEREAS Canada's European allies (Schengen Area) removed short-stay visa requirements for Ukrainian citizens in 2017 without any major security issues, including after Russia's full-scale invasion in 2022.

WHEREAS The Canada-Ukraine Authorization for Emergency Travel (CUAET) program (2022-24) safely welcomed ~300,000 Ukrainian visitors (from ~1,000,000 visas issued) demonstrating Canada can manage short-term arrivals responsibly.

WHEREAS Canada already allows tariff-free trade with Ukraine through 2017's Canada-Ukraine Free Trade Agreement (CUFTA), but restricts business, cultural, and personal travel via visa requirements.

WHEREAS Visa-free short-term travel would support Ukraine's reconstruction, strengthen bilateral trade, enable academic, sport, and cultural exchanges, and help reunite families.

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Eliminate the visitor visa requirement for Ukrainian citizens travelling to Canada for short-term stays (90 days in 180), consistent with Canada's European partners.
- This visa exemption applies only to holders of biometric passports, and uses the Electronic Authorization (eTA), as is the case for Canada's other European partners.
- This policy affirms Canada's leadership and moral commitment to supporting Ukraine and democratic values.

48085- PROTECTING CANADIAN RIGHTS TO CANADA PENSION PLAN (CPP)

Sponsor Groups: Liberal Party of Canada (Alberta)

WHEREAS the Alberta Government has proposed to withdraw from the CPP despite the preference of most Albertans polled to remain with CPP [1]

WHEREAS the Alberta Government seeks to overcome citizen opposition including through the Alberta Next panel with intent to proceed to referendum on the issue in 2026 [2] [3]

WHEREAS Canadians and their employers have contributed to CPP in the individuals' name resulting in a high sense of personal ownership of CPP contributions;

WHEREAS many seniors in Alberta fear they would be forced to leave the province to protect their Canada Pension Plan; [4][5]

BE IT RESOLVED THAT should provinces or territories create their own pension plan and withdraw from CPP, the Liberal Party of Canada urge the Government of Canada to:

- Require that anyone already in receipt of CPP have the option of continuing under the federal plan;
- Require that individuals who have contributed to CPP but have not yet withdrawn from it be given the option to stay with the federal plan or transfer their funds to the provincial plan.

70027 – CANADA STRONG HEALTHCARE

Sponsor Groups: Senior Liberals' Commission & Liberal Party of Canada (Alberta)

WHEREAS universal healthcare strengthens the economy, and lower health costs make Canada's workers more competitive, especially against the US; [1]

WHEREAS Canada performs well in life expectancy and emergency care but lags peer nations in wait times, access, efficiency and cost;

WHEREAS wait times from seeing a family doctor to specialist treatment increased 208% from 9 to 29 weeks between 1993 and 2025;

WHEREAS the 1984 Canada Health Act (CHA) promised Canadians reasonable access without charge to medically necessary hospital and physician services (with principles open to interpretation), but has not met its promise, resulting in long waits, suffering and excessive avoidable deaths; [2] [3]

WHEREAS the cost in reduced productivity and labour force participation from imaging delays alone is estimated at \$64 billion annually in lost Gross Domestic Product;

WHEREAS experts have called for CHA modernization to ensure sustainability and preserve equity and universality; [2] [3]

WHEREAS Canadians rank healthcare access among their top national concerns, with growing unease about privately paid services;

WHEREAS the Liberal Party has long prioritized universality, timely care, national standards, continuous performance monitoring and accountability;

WHEREAS a data-driven transformation to replace outdated systems with innovative, digitally connected, patient-focused models can strengthen care across Canada. [4][5]

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Modernize the CHA for the 21st century, setting measurable national standards for equitable access and consistent benefits, following models from countries with universal care; [4]
- Convene a federal–provincial–territorial panel of health system experts to establish national standards for the timely delivery of diagnostic services and treatment;
- Require publicly accessible reporting on performance against these standards, including province-specific plans and corrective measures where they are not met;
- Advance digital health, innovation, and emerging technologies to improve efficiency and sustainability, and reduce administrative burden that detracts from patient care;
- Encourage pan-Canadian licensure and mutual recognition of professional credentials, including standardized recognition of foreign qualifications; [5]

- Partner with provinces and territories to reduce interprovincial barriers, preserving and strengthening universal healthcare as a foundation of Canada's economy.

46014 - CANADIAN ARTIFICIAL INTELLIGENCE GOVERNANCE AND TRANSPARENCY ACT

Sponsor Groups: Liberal Party of Canada (Manitoba) & National Women's Liberal Commission

WHEREAS AI technologies offer major opportunities but also serious risks, including privacy erosion, data exploitation, surveillance pricing, greater concentration of wealth and power, worsening affordability crisis, and worker exploitation;

WHEREAS Canada lacks comprehensive binding AI legislation, while jurisdictions like the EU have adopted advanced risk-based frameworks, leaving Canada at risk of falling behind despite ongoing consultations and ministerial oversight.

1. **Risk-Based Regulation:** High-risk AI systems (e.g., healthcare, policing, judicial) must prove safety, fairness, and bias mitigation before deployment, with meaningful human oversight, interpretability, independent audits, strong cybersecurity, high-quality representative data, clear AI-content labeling, mental privacy protections, and ethical non-invasive brain-data handling. Limited-risk systems require transparency; minimal-risk systems have no extra obligations.
2. **Oversight and Enforcement:** Enhance the current AI oversight framework (including any commission/commissioner under ministerial authority) with true independence, provincial/territorial representation, and a scientific panel. Bar industry representatives from voting or auditing (observation only). Duties include enforcement, regular parliamentary reports on AI trends and risks, prioritized assessments for health/life/public services, and interoperability promotion to drive innovation and competition.
3. **Protections:** Ban unacceptable uses (e.g., social scoring), update privacy and labour laws to curb exploitation (including platform workers), ensure meaningful consent and accountability, enforce antitrust rules, and limit government AI use with public reporting and transparency per the Directive on Automated Decision-Making.
4. **Inclusive Services and Innovation:** Deploy AI assistants for accessible, multilingual government and judicial services supporting disabilities and diverse users; provide tax incentives, regulatory sandboxes, and international alignment to support responsible growth.
5. **Enforcement:** Impose penalties up to 7% of global annual revenue for serious violations, mandate public reporting, and establish accessible citizen redress mechanisms.
6. **Timeline:** By 2026, draft and advance CAIA; by 2027, strengthen/establish oversight bodies; by 2028, achieve full implementation. Engage diverse stakeholders, including civil society, to foster trust and inclusivity.

35356– 50 Plus 1 Electoral Reform

Sponsor Groups: Liberal Party of Canada (Ontario)

WHEREAS PM Justin Trudeau promised to replace first past the post election system as a 2015 election promise. An all-party committee was formed, and three options were discussed:

- Hold public forums to discuss options (CPC)
- Ranked ballot (LPC)
- Proportional representation (Green Party & NDP)

As no consensus was reached, electoral reform was dropped.

WHEREAS the current system can result in a candidate winning with less than a majority of votes.

WHEREAS requiring a candidate to receive at least 50% plus one vote would ensure the winner has stronger democratic legitimacy.

WHEREAS voter turnout may increase when electors can rank candidates, allowing them to vote their true preference without fear of vote-splitting.

WHEREAS ranked ballots and run-off systems can encourage more civil campaigns, as candidates may rely on second-choice support.

WHEREAS the proposal reduces the number of wasted or "dead" votes, especially in ridings where one party consistently wins.

WHEREAS ranked ballots reduce the need for multiple elections, with recounts becoming less likely.

BE IT RESOLVED that the Liberal Party of Canada urge the Government of Canada to:

- Adopt a voting system requiring candidates to receive 50% plus one vote to be elected. This may be achieved through a ranked ballot system or, alternatively, a run-off election. If a candidate receives less than 50% on the first preference count, they would be subject to recall or a subsequent vote within one year.

- Create an Indigenous Peoples Review Commission as an independent parliamentary body, headed by an Indigenous commissioner, to monitor and publicly report on progress in treaty implementation, self-government, and social well-being;
- Affirm that treaties are living agreements and foundational to the relationship between Indigenous Nations and the Canadian state, and recognize the inherent and treaty rights of Indigenous People;
- Support Indigenous-led processes to define, interpret, and implement treaty rights, including through legal, political, and educational means;
- Work in full partnership with Indigenous Nations to implement treaties in the spirit and intent in which they were entered;
- Legislate protections against forced relocations of Indigenous communities, amending the Canadian Human Rights Act to prohibit relocations without free, prior, and informed consent.
